

AUSTRALIA SQUARE / SPIN THE WHEEL COMPETITION  
**Terms and Conditions**

1. These terms and conditions are for all entrants who enter the Spin the Wheel Centre Promotion (“Promotion”). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The “Promoter” is Australia Square, Dexus Funds Management Limited (ABN: 24 060 920 783) as Trustee for Dexus Australia Square Trust (ABN: 20 572 686 455), GPT RE Limited as Trustee for General Property Trust. The address is 264 George Street, Sydney NSW 2000

**ELIGIBILITY**

4. Subject to condition 3, this Promotion is only open to Australian residents [aged 18 years or over].
5. The following are ineligible: (i) employees of the Promoter, Dexus or any of the tenants or retailers in the Participating Centre/s or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

**PROMOTION PERIOD**

6. This Promotion commences daily (excluding weekends) at 11:00am – 2:30pm Monday 20 November 2023 (“AEST”) and ends Friday 1<sup>st</sup> December 2023 (AEST) (“Promotion Period”).

**HOW TO ENTER**

To enter the Australia Square Spin the Wheel competition, customers must do the following during the Promotional Period:

1. Make a minimum spend of \$15 or more in one transaction at participating stores.  
Participating stores are Australia Square Dining retailers.
2. Present receipts to the staff at the promotional wheel located in the lobby of Australia Square. Receipts will be marked as evidence they have been used for a spin on the promotional wheel. The wheel will be staffed between 11:00am to 2.30pm on weekdays.
3. Each customer has a turn to Spin to Win wheel for a chance to win a prize.
4. Customers are permitted one entry per day during the promotional period.

**CONDITIONS OF ENTRY**

All entrants will win the prize corresponding to the wedge that the spinner/needle lands on.

If the needle/spinner lands on the “Entry into \$1000 Luxury Escapes Draw”, the entrant will be given one entry into the draw for a chance to win the Holiday Package prize.

Once all available units of a prize have been won, the respective prize wedge will be replaced with a “Entry into \$1000 Luxury Escapes Draw” wedge. The prize will be awarded to each winner by a promotional staff member upon completion of their spin attempt.

If there is a dispute as to which wedge the spinner/needle lands on, the promotional staff member's decision will be final. Once all available prizes have been awarded the spinning game will conclude. The entrant must not interfere with the wheel once the wheel is spun. Any unfair conduct in participating in the wheel will see the entrant disqualified.

Retail prize vouchers where there is a choice of two retailers are awarded via lucky dip. The customer will pick an envelope and win the prize inside. Prizes will match the wedge on which they landed for example, if they land on "Guzman Y Gomez or Cali Press \$15 Voucher", the envelope they pick will reveal which voucher they have won. Envelope reveal is final and cannot be exchanged.

Retail vouchers must be redeemed by 22 December 2023 and O Bar & Dining vouchers will be valid for 3 years from the date of issue or will be forfeited.

It is a condition of entering the Promotion that entrants agree for their personal information to be added to the Promoters database and to be used in accordance with the purposes set out in these Terms and Conditions.

### LIMITS ON ENTRY

Limit one (1) spinning wheel attempt permitted per eligible person each day.

## **PRIZE DRAW**
